### **Pollinating London Together - a Pan Livery opportunity**

Subject to recovery to a more normal life from the virus, on Wednesday 16 September, Mansion House, Wax Chandlers and Grocers Halls will be a part of a day of innovative events in support of 'Pollinating London Together'. The purposefully positive programme will aim to bring together as many Livery Companies as possible in a shared initiative to raise awareness of the importance of flowers, trees, shrubs and habitat in providing food and homes for pollinators in every month of the year; this is central to our food security.

The Mansion House session, kindly hosted by the Lady Mayoress, will cover important trending topics such as: Food security for the future; The relevance of pollination to business; How to raise awareness of our individual roles as pollination saviours; and What we can do to re-green the City and its potential impact on our health and wellbeing.

Wax Chandlers, as one of the instigators, plan to host cultural events to demonstrate the wider wonder of all three bees – solitary bees, bumblebees and honey bees - through their gifts of health, food, honey, wax, mead, music, bomb-detection, communication, teamwork and acknowledged inspiration for The Flight of the Bumblebee orchestral interlude. There will also be a dinner at Grocers Hall.

This annual fund-raising event will, in future years, cover other pollinators and other ecological issues, to which the City and its Livery Companies can lend their valuable weight.

### **The Lord Mayor and Policy Chair's Virtual Engagement Programme**

From an international dimension the Lord Mayor and the Policy Chair have been working together to speak to Her Majesty's Trade Commissioners, the nine senior Government officials responsible for trade and investment policy around the world, working with them to identify how best the City of London Corporation can apply its expertise and resources to support the UK's trading relationships with our most important overseas partners. While their overseas visits may have been postponed, the Lord Mayor and the Policy Chair have been having positive conversations with Ambassadors and High Commissioners representing key overseas markets, and plans are in place to carry out a virtual programme of international events and engagements.

In the wider response to COVID-19, the City Corporation has been playing its part. Its focus has been on supporting businesses and communities, not just in the Square Mile but also across Greater London. The City Corporation is providing financial support through the City Bridge Trust to the most vulnerable and working closely with frontline agencies. London's Strategic Coordination Group, which is coordinating the pan-London response to this crisis, is being led by the Town Clerk and Chief Executive of the City Corporation, John Barradell. As ever, the City Corporation is seeking to be the interface between businesses of all sizes and Government, to ensure that policy-makers understand the issues facing the financial and related professional services sector, and that support is supplied in the optimal way. The priority is to maintain confidence in the City, especially among international audiences. The resilience and agility of the financial and professional services industry will be central to the long-term economic recovery, both in the UK and globally.

Culturally, too, the Lord Mayor has reached out to key cultural institutions within the City to express his gratitude and sympathy, outlining that they remain a major priority for him and his mayoral programme. Both the Lord Mayor and the Policy Chair have written to residents within the City to outline the work they are doing, as well as the support that is available to them.
